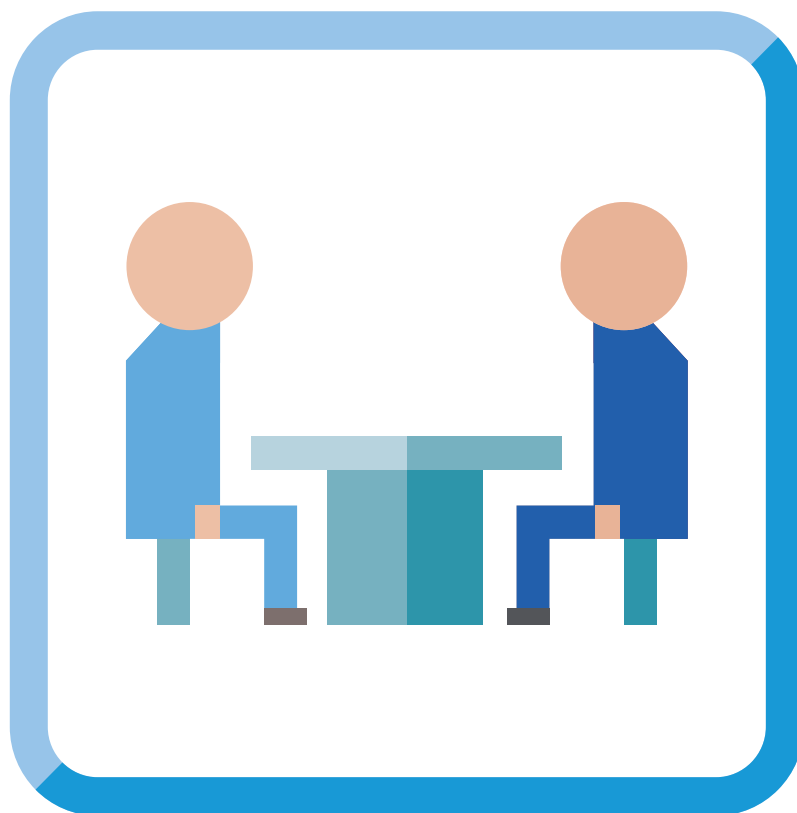

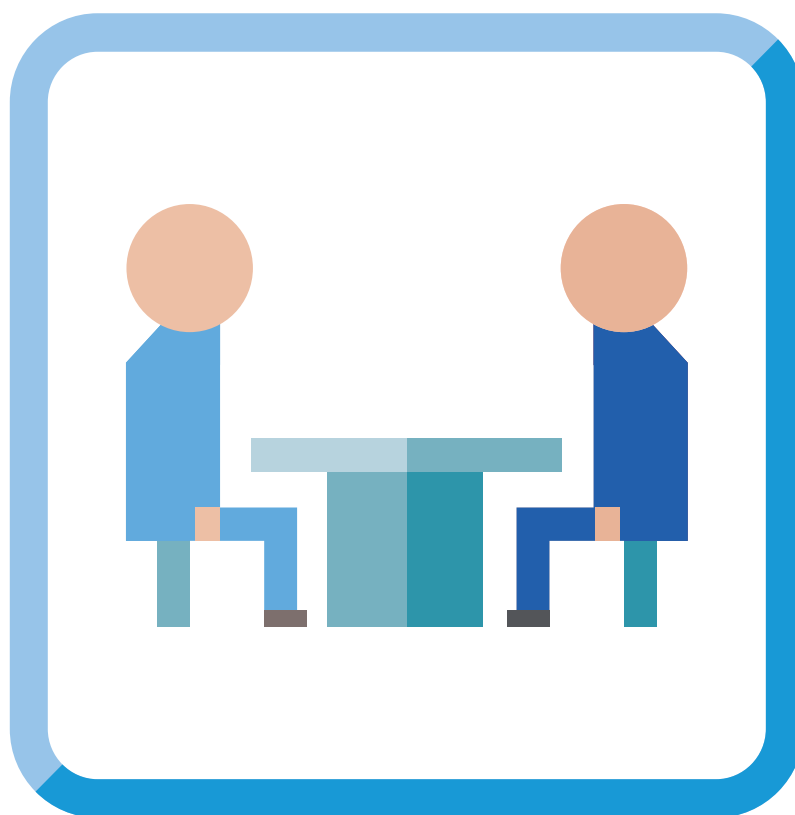

WE REMIND CUSTOMERS THAT EACH TABLE CAN ACCOMMODATE NO MORE THAN 4 PATRONS AND THAT THE MINIMUM DISTANCE BETWEEN THEM MUST BE NO LESS THAN 1 METRE, WITH THE EXCEPTION OF LIVE-IN FAMILY MEMBERS AND INDIVIDUALS WHO ARE EXEMPT FROM THE MINIMUM SOCIAL DISTANCING REQUIREMENTS PURSUANT TO CURRENT STATUTORY PROVISIONS. COMPLIANCE WITH PHYSICAL DISTANCING MEASURES IS LEFT TO THE PERSONAL RESPONSIBILITY OF EACH AND EVERY CUSTOMER.
